That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 23rd day of May, 1963, I found the North 1/16 corner of sections 29 - 30 which was evidenced by the remains of the GLO resurvey of 1926

Iron post 1 inch diameter with a brass cap stamped:
