

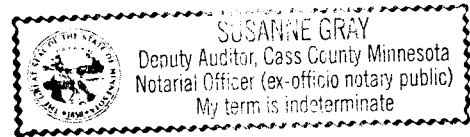

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 4th day of January, 1963,

I found the center north 1/16 corner of section 28

which was evidenced by a 1 inch diameter iron post with brass cap marked :-

 1926

This corner was set by the General Land Office survey of 1926.

No evidence of the bearing trees was found.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument was set as the G.L.O. brass cap is in good condition.
