

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 7th day of January, 1963, I found the north $1/16$ corner of sections 27-28

which was evidenced by a monument and two bearing trees from a survey by the General Land Office in 1926.

Monument is a 1 inch diameter iron post with brass cap stamped

N $1/16$
 S28 | S27
 1926

Spruce 6 inch S63°E 29 links or 19.14 feet (now a spruce stump S63°E 19.14 feet with scribe visible.)

Cedar 10 inch N73 $\frac{1}{2}$ °W 32 links or 21.12 feet (now a 12 inch cedar N73°W 21.12 feet with scribe visible.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Cedar 8 inch N36°E 5.8 feet marked N $1/16$ S27 BT

Cedar 11 inch S35°W 22.72 feet marked N $1/16$ S 28 BT

Steel sign post 72 inches long set 24 inches in the ground with signs 54-2 and 54-4 attached due North 8.07 feet.

All reference bearings are true bearings.
