, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 22nd day of May, 1963,

I found the Center 1/4 corner of Section 30 which was evidenced by the remains of the General Land Office survey of 1926.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

Cedar 8 inch N39½°E 28 links (18.48 feet) (Now a 10 inch cedar at record bearing and distance with scribe "C¼" visible.) C ¼ S30 1926

Cedar 8 inch S80°W 44 links (32.34 feet) (Now a 12 inch cedar at record bearing and distance with scribe decayed.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as G.L.O. monument is in good condition.

from which reference or witness monuments are located in the manner following:

Cedar 7 inch S10°W 18.1 feet marked "C¼ BT"

Cedar 7 inch S65°E 12.1 feet marked "C¼ BT"

Steel sign post 72 inches long, set 24 inches in ground with Forest Service signs 54-2 and 54-4 attached due West 4.0 feet.
