



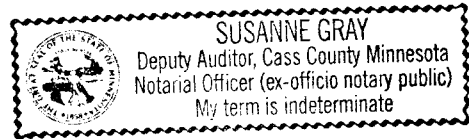

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:  
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3629.  
 I further depose and say that on the 8th day of January, 1963, I found the Quarter corner of sections 28 - 29 which was evidenced by the remains of a General Land Office survey of 1926.

Found a 1 inch diameter iron post with brass cap stamped marking corner.

Poplar 12 inch N75°E 28 links or 18.48 feet (now a decayed stump N75°E 18.48 feet.)

no other bearing trees were found.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Maple 12 inch N75°E 23.5 feet marked 1/4 S 28 BT

Maple 11 inch S7°E 20.05 feet marked 1/4 S 28 BT

Steel sign post 72 inches long set 24 inches in ground with signs 54-2 and 54-4 attached due North 6.4 feet.
