



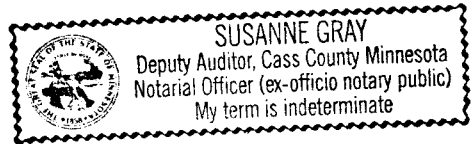

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 8th day of January, 1963, I found the South 1/16 corner of sections 28 - 29

which was evidenced by the remains of a survey by the General Land Office in 1926.

Found a 1 inch diameter iron post with brass cap stamped S1/16 marking corner.

Poplar 7 inch N41°E 15 links or 9.9 feet (now a 5 inch birch N50°E 9.9 feet scribed S1/16 S28 BT.)

Poplar 7 inch S87°W 25 links or 16.5 feet (now a 14 inch aspen S87°W 15.5 feet with scribe overgrown.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.)

from which reference or witness monuments are located in the manner following:

Spruce 14 inch S75°W 42.6 feet Marked S 29 BT

Elm 4 inch S10 1/2°E 9.45 feet Marked S 28 BT

Steel sign post 72 inches long, set 24 inches in the ground with signs 54-2 and 54-4 attached due North 8.35 feet.

All reference bearings are true bearings.
