





## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 4th day of January, 1963,

I found the center south 1/16 corner of section 28 which was evidenced by a 1 inch diameter iron post with brass cap and one remaining bearing tree from the General Land Office survey of 1926.

The brass cap is stamped:-

Tamarack 14 inches N7 $\frac{1}{2}$ <sup>0</sup>W 31 links or 20.46 feet (now a tamarack stub N7 $\frac{1}{2}$ <sup>0</sup>W 20.46 feet with scribing visible.) and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
