being first duly sworn, deposes and says:  
 That I reside at Cass Lake Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of September, 1962, I found the East 1/16 corner of Sections 30-31 which was evidenced by two bearing trees from the G.L.O. survey of 1926

Maple 10" S 54 1/2° E 49 Lks or 32.34 feet (Now a 14" maple S 51 1/2° E 32.34' with scribe overgrown).  
 Maple 10" N 0° 30' W 38 Lks or 25.08' (Now a 14" Maple N 4° E 25.08' with scribe overgrown).

Corner was found to be marked by a 1" dia. iron post with a brass cap stamped:
