





Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 8th day of January, 1963, I found the section corner of sections 28-29-32-33

which was evidenced by the remains of a survey by the General Land Office in 1926.

Found a 2 inch diameter iron post with brass cap stamped T144N R29W marking corner.
