



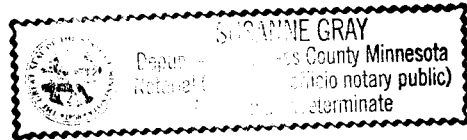

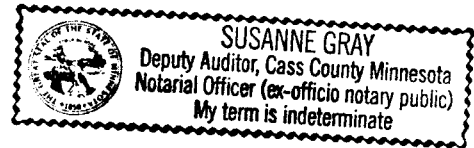

....., being first duly sworn, deposes and says:  
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. ....

I further depose and say that on the 19th day of September, 1962, I found the North East 1/16 corner of Section 31 which was evidenced by two bearing trees from the G.L.O. survey of 1926

Elm 8" S 24½° W 31 Lks or 20.46 feet (Now a 9" Elm S 27° W 20.4 ft. w/ center decayed)

Maple 14" N 35¼° W 76 Lks or 50.16 feet (Now a 16" Maple N 35¼° W 50.16 feet w/ scribe "1/16 S 31 visible.)

Corner was found to be marked by a G.L.O. iron post w/ brass cap stamped: - NE 1/16 S 31 1926

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as G.L.O. brass cap is in good condition.
