being first duly sworn, deposes and says:
That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of September, 1962, I found the North 1/16 corner of Sections 32-33 which was evidenced by two bearing trees of the G.L.O. survey of 1926.
Poplar 6" S47°30' E 10 links or 6.6 feet (Now a Aspen stub with "window" facing corner S47½°E 6.6 feet)
Poplar 6" N44°30'W 44 links or 29.04 feet (Now a stump hole at record bearing and distance)
Corner was found to be marked by a G.L.O. iron post with a brass cap stamped:-

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. brass cap is in good condition.
