







, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of September, 1962, I found the Center West 1/16 corner of Section 31 which was evidenced by two bearing trees from the G.L.O. survey of 1926

Maple 18" N 30° W 15 Lks or 9.9 feet (Now a 20" Maple N 30° W 9.9 feet with scribe overgrown)

Maple 8" S 10° W 26 Lks or 17.16 feet (Now a 11" Maple S 13° W 17.16 feet with scribe overgrown).

Corner was found to be marked by a G.L.O. iron post with brass cap stamped: -

 S 31

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the G.L.O. brass cap is in good condition.
