

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628
 I further depose and say that on the 20th day of September, 1962,
 I found the Center Quarter corner of Section 31
 which was evidenced by two bearing trees from the G.L.O. survey of 1926,
 Maple 6" N41/2°E, 17 Links or 11.22 feet (now a 12" Maple N41/2°E, 11.22 feet, scribe overgrown)
 Elm 14" S15 1/2°E, 59 Links or 38.94 feet (now a burned windfall S11°E, 38.94 feet)

Corner was found to be marked by a G.L.O.
 iron post with brass cap stamped:-

C 1/4 S 31
 1926

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. brass cap is in good condition.
