William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 2nd day of June, 1964, I found the East 1/16 corner of sections 5-8 which was evidenced by a 1" iron pipe set by Chippewa National Forest Engineer Meyer on 1956 and verified by survey by myself.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch inside diameter 60 inches long galvanized steel monument filled with concrete and capped with a 3 inch diameter bronze tablet stamped -
