William H. Okerman, being first duly sworn, deposes and says:
 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.
 I further depose and say that on the 14th day of June, 1966, I found the Quarter corner of Sections 4-9 which was evidenced by G.L.O. resurvey of 1937 a set iron post 3 feet long 1 inch in diameter with brass cap marked $\frac{1}{4}$ S4 1937
 Spruce 6 inch N32 $\frac{1}{2}$ °E 8 links or 5.28 feet - Now a decayed log at correct bearing and distance - scribe visible.
 Norway Pine 12 inch S50°E 32 links or 21.12 feet - Now a 18 inch Red Pine at correct bearing and distance.
 and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set, used G.L.O. brass cap.
