, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 2nd day of June, 1964, I found the North 1/16 corner of Sections 8 - 9 which was evidenced by 1" iron pipe set by Chippewa National Forest Engineer Meyer in 1956 and verified by survey by myself.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch inside diameter 60 inch long galvanized steel monument

filled with concrete and capped with a 3 inch diameter bronze tablet marked -

from which reference or witness monuments are located in the manner following:

Red Pine 22inch S24°E 291.0 feet scribed N 1/16 S9BT

Steel sign post 72 inches long due south 9.0 feet with sign 54-2 attached
