



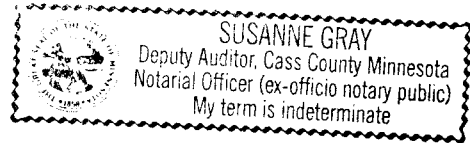

, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 18th day of September, 1964, I found the Section corner of Section's 7-8-17-18 which was evidenced by the remains of the G.L.O. resurvey of 1937 which was the bottom part of a 6" dia. Cement Monument.

N. Pine 8" N15 1/4° E 145.86' (Now a pine snag at record bearing and distance with scribe T114N R27W S8BT visible)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6' diameter 60" long Cylindrical Concrete Monument capped with a 3" diameter bronze tablet stamped.
