Okerman, being first duly sworn, deposes and says: That I reside at Bemidji Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No....6807 I further depose and say that on the 16th day of September 19 64 corner of sections 8 & 17 which was evidenced by the remains of the G.L.O. resurvey in 1937 which was two BT's. Birch 6" N64°E 93.7' MKD T144N R27W Section 8, MCBT (Now a decayed Birch stump with scribe marks visible at record bearing and distance) Poplar 10" S39°E 163.7' MKD T144N R27W S 17 BT (Now a decayed log with scribe mark visible at record bearing and distance) and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 5' long 2" inside diameter filled with concrete galvanized steel post. capped with a 3" diameter bronze tablet stamped: TILLIN from which reference or witness monuments are located in the manner following: 1964 4"x4"x60" red top Cedar post due East 7.2' RLS No. 6807

4"x4"x60" red top Cedar post 37°E 8.2' with sign 54-4 attached


