William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 24th day of June, 1966, I found the Quarter corner of Sections 10 - 15

which was evidenced by G.L.O. resurvey of 1937 a set iron post 3 feet long by 1 inch in diameter with brass cap marked:

Tamarack 9 inch S22°W 297 lks or 196.02 feet - Now a dead Tamarack at correct bearing and distance - scribe visible.
