That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 1st day of July, 1966, I found the Quarter corner of Section's 17-20 which was evidenced by G.L.O. resurvey of 1937

a set iron post 3 feet long 1 inch diameter with brass cap marked

Birch 5 inch S9 $\frac{1}{4}$ °E 25 links or 16.50 feet - Now a Birch stump at correct bearing and distance - scribe visible.
