That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 19th day of June, 1966, I found the Quarter corner of Sections 26-27 which was evidenced by G.L.O. resurvey of 1937. a set iron post 3 feet long 1 inch diameter with brass cap marked
