That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 19th day of June, 1966, I found the Quarter corner of Section's 26-35 which was evidenced by G.L.O. resurvey of 1937

a set iron post 3 feet long 1 inch in diameter with brass cap marked $\frac{1}{4}$ S 26

Tamarack 5 inch S88°E 290 links or 191.40 feet - Now a 10 inch Tamarack at correct bearing and distance.
