That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.....

I further depose and say that on the 17th day of June , 19 66, I found the Quarter corner of Section's 22-27

which was evidenced by G.L.O. resurvey of 1937
a set iron post 3 feet long 1 inch in diameter with brass cap marked $\frac{1}{4}$ S 22

Maple 7 inch S57°E 29 links or 19.14 feet - Now a Maple snag at correct bearing and distance - scribe visible. $\frac{1}{4}$ S 27 1937

Spruce 12 inch N14 $\frac{1}{2}$ °W 62 links or 40.92 feet - Now a decayed stump at record bearing and distance.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set, used G.L.O. brass cap.
