William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 10th day of June, 1966, I found the Quarter corner of Sections 23-26 which was evidenced by G.L.O. resurvey of 1937

a set iron post 3 feet long 1 inch in diameter with brass cap marked  $\frac{1}{4}$  S 23  
Burr Oak 14 inch N39-3/4°W 63 links or 41.58 feet - Now a 18 inch at  $\frac{1}{4}$  S26  
correct bearing and distance-blaze visible. 1937

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set, used G.L.O. brass cap

from which reference or witness monuments are located in the manner following:

G.L.O. Burr Oak 18 inch N39-3/4°W 41.58 feet - rescribed  $\frac{1}{4}$  S23 BT.Oak 6 inch S80°E 92.9 feet - scribed  $\frac{1}{4}$  S26 BT.

Set a steel sign post 72 inches long with signs 54-2 and 54-4 attached due West 5.5 feet.
