








That I reside at Bemidji , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.....

I further depose and say that on the 12th day of September , 19 69 .. , I found the Quarter corner of Sections 15-16 which was evidenced by remains of the G.L.O. resurvey of 1922 consisting of 2 inch diameter iron post 3 feet long with brass cap marked

Found brass cap in meadow 18 inches above ground.
