That I reside at Bemidji, Minnesota and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 6th day of October, 1965, I found the Section corner of Sections 10-11-14-15 which was evidenced by remains of old foundation for schoolhouse which was described by John Curo in 1913, Cass County Surveyor.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 24 inch long cylindrical concrete monument capped with

a 3 inch diameter bronze tablet stamped:
