William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 24th day of June, 1964, I found the Quarter corner of Sections 32 - 33

which was evidenced by remains of a survey by Cass County Surveyor J. H. Flynn in 1924. Set 2 Cedar post for witness to true corner at right angles.

(Found Cedar Post broken off - found stump hole 66" apart.)

(Found Point of post in wheel track of abandoned road.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter, 60" long cylindrical concrete monument, capped with a 3" diameter bronze tablet stamped:

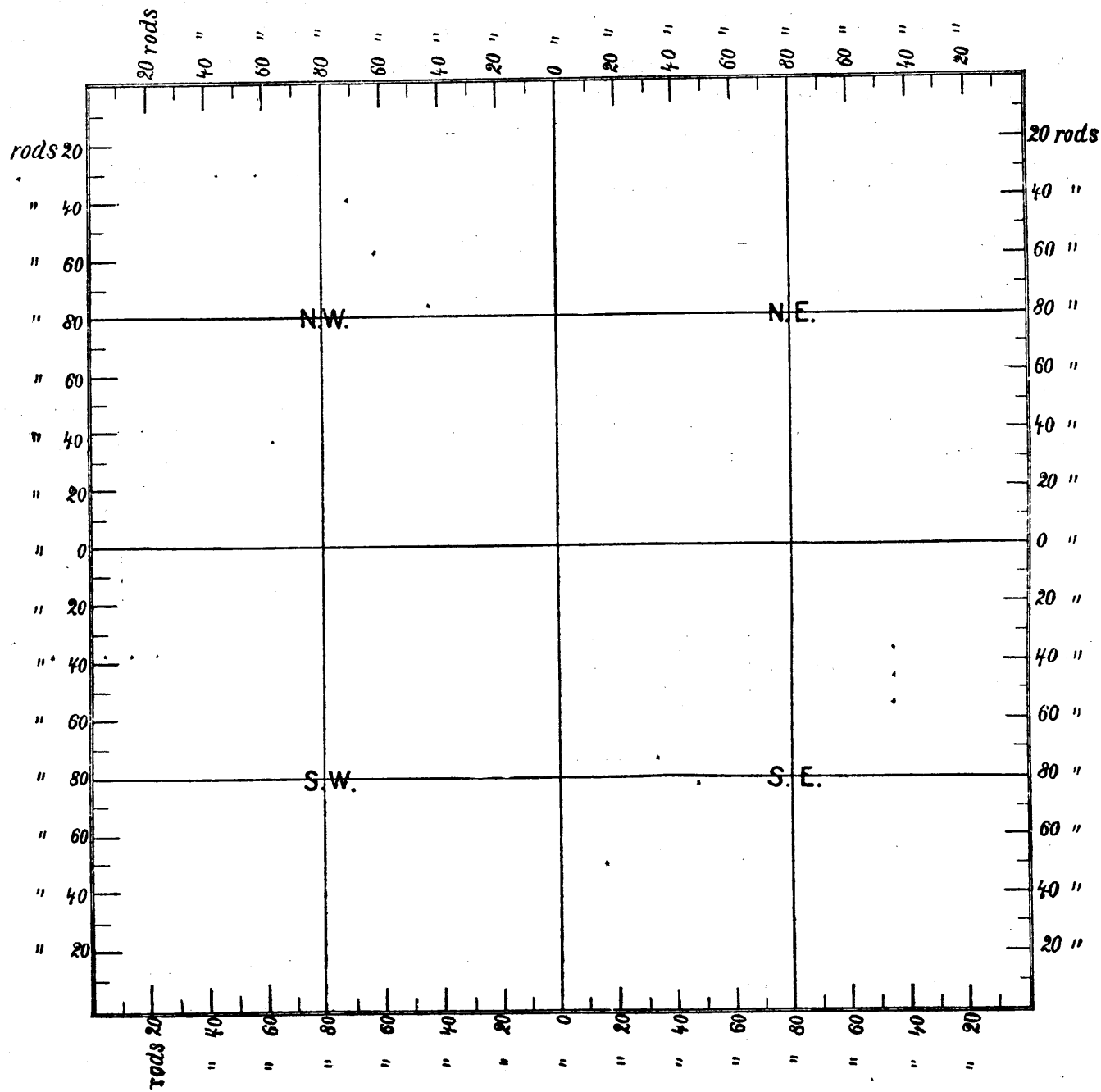
