







William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 25th day of October, 1966, I found the Meander corner of Sections 33-34 which was evidenced by remains of the original government survey of 1872.

Found scribed post.

Spruce 6 inch west 3 links - now fallen and rotted but BT scribe visible, west 1.98 feet.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 5 foot long cylindrical concrete monument with brass cap stamped
