That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 6th day of July, 1967, I found the Standard Section corner of Sections 35 - 36 which was evidenced by remains of the G.L.O. resurvey of 1926, consisting of 2 inch diameter iron post, 3 feet long with brass cap marked:

N. Pine 14 inch N42°W 56.76 feet - now 18 inch at record bearing and distance with scribe visible.
