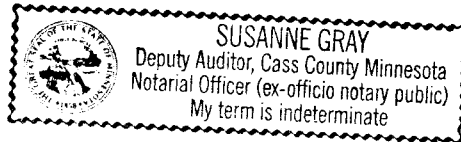



AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec. 2 - 11 T. 145 N R. 27 W No. 26

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of November, 1958, I found the 1/4 corner of sections 2-11 which was evidenced by two remaining original scribed bearing trees of the Government Survey of 1873.

(1) 4 inch Tamarack (now 5 inch dead stub with scribing visible) N 65° W, 70 links or 46.2 feet.

(2) 3 inch tamarack (now 5 inch windfall with scribing visible) S 40° W, 38 links or 25.1 feet.

I checked and found no evidence of original Government corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

T 145 N R 27 W
 1/4 2-11
 1958
 R.L.S. 3628

from which reference or witness monuments are located in the manner following:

5 inch tamarack	S 40½° E	33.2 feet
6 inch B. Spruce	S 68° W	33.7 feet
5 inch B. Spruce	N 11½° W	50.3 feet

All reference bearings are true bearings.
