## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec. 10-11 T. 145 N R. 27 W No. 7

County of Cass } ss.Peter J. Meyer, being first duly sworn, deposes and says:  
That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of November, 1958, I found the 1/4 corner of sections 10-11 which was evidenced by one remaining original scribed bearing tree of the government survey of 1873. (1) 6 inch Jack pine (now 17 inch dead tree with scribing visible) N 75° E, 90 links or 59.4 feet. I checked and found no evidence of original government corner or original government bearing trees. Corner was found to be marked by 4 inch x 4 inch stake.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

1958  
R.L.S. 3628
