





That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd. day of April, 1964,

I found the Closing corner of Sections 3 - 4 which was evidenced by remains of the G.L.O. resurvey of 1930 consisting of 2 inch diameter iron post, 3 feet long with brass cap marked:

Found post as described.
