William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 3rd day of April, 1964, I found the North Quarter corner of Section 3 which was evidenced by remains of the G.L.O. resurvey of 1930 consisting of 1 inch diameter iron post, 3 feet long with brass cap marked:

Found post as described.

Elm 12 inch S23°E 96.50 feet - now 13 inch S22°E 95.60 feet, cut section from overgrown scribing, in good condition.

W. Pine 21 inch S40°W 45.50 feet - now 29 inch S41°30'W with scribing partially visible.
