, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of May, 1963, I found the North Quarter corner of Section 2 which was evidenced by the remains of the G.L.O. Survey of 1926.

Corner was found to be marked by a iron post with a brass cap stamped:-

White pine 16" S48°E 40 links (26.4 feet)(Now a 26 inch pine stump and log with scribe visible at record bearing and distance.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

White spruce 12 inch S38°W 33.55 feet marked 1/4 S2 BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due South 3.9 feet.

Cedar post 4x4x72 inches, penta-treated and with red top, set due West 75.7 feet. Post is on the South edge of LUR road.

All reference bearings are true bearings.
