Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 16th day of May, 1963, I found the closing corner of Sections 1-2 which was evidenced by the remains of the G.L.O. resurvey of 1926.

Corner was found to be marked by a 2 inch diameter iron post with a brass cap stamped:-

Cedar 10" S38°E 40 lks (26.4 feet)(Now a 12" cedar S38°E 26.4 feet with scribe visible.)

Steel sign post 72 inches long, set 24 inches in ground with signs 54-2 and 54-4 attached due West 4.0 feet.

Angle point for original closing corner bears South 48 links or 31.68 feet.

All reference bearings are true bearings.
