Meyer , being first duly sworn, deposes and says: laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628 I further depose and say that on the lst day of December , 19 61, I found the East 1/16 corner of sections 1 - 12 which was evidenced by the G.L.O. survey of 1926:-Iron post 1th dia. 3' long with a brass cap marked 1926 Red oak 6 547 3/4 E 35 links or 23.10 (now a 11 red maple S47 E 23.11 with scar facing corner)

White pine 6th N8820W 20 links or 13.20' (now a 13th Jack pine N850W 13.2' with scribe and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument sat - G.L.O. post with brass cap is in place.
