





Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 11th day of December, 1961, I found the Quarter corner of Sections 10 - 11

which was evidenced by remains of a survey by G.L.O. in 1926, notes of this survey are filed in the Minnesota state capitol, St. Paul, Minnesota.

Iron post 3' long 1" dia. with brass cap marked:

S10 | S11

Cedar 10" S85°15'E 42 links or 27.72' (now a 14" cedar S85°E 27.72' with scribe $\frac{1}{4}$ " S BT visible)

Birch 8" S32°15'W 16 links or 10.56' (now a birch windfall S32°W 10.6' with scribe $\frac{1}{4}$ " S 10 BT visible)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set - brass capped iron post is in place.
