, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 31st day of July, 1961, I found the Quarter corner of Sections 11-12 which was evidenced by the remains of the G.L.O. resurvey of 1926.

Corner was found to be a iron post 1 inch diameter with a brass cap stamped:-

Dead Jack pine 12" N5 $\frac{1}{2}$ °E 14.52 feet (Now a jack pine stump marked "BT*")

Jack pine 12" S49°E 48 links (31.68 feet)(Now a pine stump S55°E 31.68 feet.)

Red Pine 12" S56 $\frac{1}{4}$ °W 59 links (38.94 feet)(Now a 16" Red pine S53°W 38.94 feet with scribing visible.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as the G.L.O. brass cap is in good condition.

Cedar post 4x4x78 inches penta-treated and with red top set due West 0.75 feet with standard sign 54-4 attached.
