





AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 2nd day of August, 19 63,

I found the center North 1/16 corner of Section 14 which was evidenced by the remains of the G.L.O. Survey of 1926.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

Balsam 10" S86°E 48 links (31.68 feet)(Now a 18" Balsam S86°E 31.6 feet with scribe decayed.)

Elm 10" S68½°W 30 links. (19.8 feet)(Now a 14 inch elm S75°W 19.8 feet with scribe overgrown.)

Steel sign post 72 inches long, set 24 inches in ground, with standard signs 54-2 and 54-4 attached due South 3.65 feet.
