





AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Center Quarter

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 10th day of January, 1963, I found the center quarter corner of section 21

which was evidenced by the remains of a survey by the General Land Office in 1926.

Found a 1 inch diameter iron post with brass cap stamped C $\frac{1}{4}$ S 21 marking corner.
1926Cedar 5 inch N18 $\frac{1}{2}$ ⁰E 20 links or 13.2 feet (now a 7 inch cedar ~~XXXX~~ with scribe decayed N20⁰E 13,2 feet,)Cedar 6 inch S1 $\frac{1}{2}$ ⁰E 41 links or 27.06 feet (now a cedar stump S3⁰E 27.06 feet.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Ash 8 inch N42⁰W 20.5 feet marked C $\frac{1}{4}$ S 21 BTWhite Pine 9 inch N78⁰E 22.0 feet marked C $\frac{1}{4}$ S 21 BT

Steel sign post 72 inches long, set 24 inches in the ground, with signs 54-2 and 54-4 attached due East 4.5 feet

All reference bearings are true bearings.
