

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 7th day of March, 1963, I found the Quarter corner of sections 22 - 23 which was evidenced by the remains of the G.L.O. resurvey of 1926. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

Ironwood 4" N83°15'E 22 links (14.52')(now a decayed stump	1/4
N82°E 14.5 feet)	S 22   S 23
Ironwood 6" N62°W 26 links (17.16')(now a stump hole N65°W 17.16 feet)	1926

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Maple 8 inch N11°E 17.95 feet MKD 1/4 S 23 BT

Maple 9 inch S80½°E 24.15 feet MKD 1/4 S 23 BT

Maple 11 inch S64°W 39.9 feet MKD 1/4 S 22 BT

Set a steel sign post due south 5.0 feet with signs 54-2 and 54-4 attached.
