



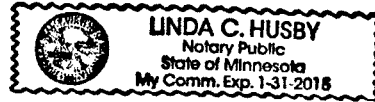

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 8th day of October, 1963, I found the Quarter corner of sections 36-31

which was evidenced by remains of original government survey post alongside of iron pipe

Notes of Jr. Civil Engineer R. T. DeFant

Tamarack 6" N60°W 35.2' scribed $\frac{1}{4}$ " S36 BT (found with scribe visible)

Tamarack 6" N85°E 73.5' scribed $\frac{1}{4}$ " S31 BT (found with scribe visible)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 60" long galvanized steel Monument filled with

concrete and set 36" in ground Capped with a 3" diameter Bronze tablet stamped.

Tamarack 4" N61°E 19.4 feet scribed S31BT

Spruce 4" S30°W 19.7 feet scribed S36BT

Steel sign Post 72" long 24" in ground due east 3.7 feet with signs 54-4 and 54-2 attached.
