Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 6th day of May, 1963,

I found the Quarter corner of Sections 31 - 32 which was evidenced by two bearing trees from the General Land Office survey of 1934.

Jack pine 9 inch N41°E 59 links or 38.94 feet (Now a jack pine stump scribed "¼ S32 BT" at record bearing and distance.)

Jack pine 12 inch S39¼°W 38 links or 25.08 feet (Now a 18 inch jack pine with scribe partly overgrown at record bearing and distance.)

No evidence of the G.L.O. brass cap was found.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter, 5 foot long, cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped:-

from which reference or witness monuments are located in the manner following:

Jack pine 5 inch N22°E 6.4 feet marked "¼ S32 BT"

Steel sign post 72 inches long set 24 inches in ground with signs 54-2 and 54-4 attached due south 3.9 feet.
