





, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 14th day of October, 1965, I found the Section corner of Sections 1-2-35-36 which was evidenced by remains of G.L.O. resurvey of 1933. Consisting of a cylindrical concrete monument with cap broken off.

Oak 8 inch N37°E 61 links or 40.26 feet - Now a 12 inch Oak - scribe overgrown.

Oak 8 inch S56°E 54 links or 35.64 feet - Now a Oak snag.

Oak 6 inch S49°W 42 links or 27.72 feet - Now a 8 inch Oak - scribe overgrown.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 5 foot long 2 inch inside diameter steel pipe with a 3 inch diameter bronze tablet stamped
