





That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807I further depose and say that on the 30th day of July, 1964,
I found the section corner of Sections 11-12-13-14
which was evidenced by remains of Forest Engineer Gelhaug of 1934R.Oak 4" N.55°W 7 links (4.6') (now a 6" oak 5.5' N.52°W. scribe overgrown rescribed B.T.)
W.Oak 4" N.60½°E. 37 links (24.4) (now an 8" oak at record bearing and distance, scribe overgrown rescribed B.T.)
W.Oak 4" S.88½°E. 39 links (25.7') (now a 6" oak at record bearing and distance, scribe overgrown rescribed B.T.)
R.Oak 4" S.12°W. 29½ links (19.5') (now a 8" oak at record bearing and distance, scribe overgrown rescribed B.T.)
