Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 15th day of May, 1962, I found the Quarter corner of Sections 26 - 35 which was evidenced by one remaining bearing tree from the original Government Survey of 1874. N. Pine 18" N28°W 25.08' (38 Links) (Now a dead N. Pine tree with scribe plainly visible N28°E 25.08 feet)

Corner was found to be marked by a fallen scribed oak post set by registered Land Surveyor J. A. Gjelhaug in 1937, a plat of his survey is filed in Forest Supervisor's Office, Chippewa National Forest, Cass Lake, Minnesota.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 5 foot long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:
