





That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
I further depose and say that on the 28th day of August, 1962, I found the Section corner of Sections 1-2-35-36 which was evidenced by remains of the G.L.O. re-survey of 1933.
