Peter J. Meyer, being first duly sworn, deposes and says:
That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
I further depose and say that on the 28th day of August, 1962, I found the Quarter corner of Sections 1 - 6 which was evidenced by remains of the G.L.O. re-survey of 1933:

Iron post 1" diameter 3' long with brass cap marked 1/4 (Found in place)
S1 | S6
1933

Tamarack 4" N62 $\frac{1}{2}$ °E, 28 links or 18.48' (now a 5"
Tamarack N62 $\frac{1}{2}$ °E, 18.48' scribe visible)
Spruce 8", N39 $\frac{1}{2}$ °W, 18 links or 11.88' (now a decayed spruce stump N39 $\frac{1}{2}$ °W, 11.88')

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as brass cap is in place.
