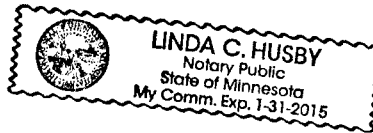

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 11th day of May, 1966, I found the Quarter corner of Sections 10-11 which was evidenced by remains of the G.L.O. resurvey of 1933 consisting of a 1 inch diameter iron post with brass cap marked:

Jack Pine 8 inch S28°E32 links or 21.12 feet - now a pine stump at record bearing and distance with scribe visible.
