William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 4th day of May, 1966, I found the Center North 1/16 corner of Section 13 which was evidenced by two remaining scribed bearing trees of the G.L.O. survey in 1933 at Norway Pine 1 1/4 inch N54 1/2°E 18 lks or 11.88 feet - Now a decayed stump/bearing and distance-scribe visible.

Norway Pine 1 1/4 inch N5°W 35 lks or 23.10 feet - Now a decayed stump at bearing and distance.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of 2 inch diameter 5 foot long galvanized steel pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped
